CONTRACT AGREEMENT

For "Improvement/Repair of Existing Policy Development and Planning Bureau Ceiling and Reconditioning of Electrical Wiring and Fixtures"

KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Batasan Pambansa Complex, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Policy and Plans, **LUZVIMINDA C. ILAGAN** (hereinafter called the "Entity");

-and-

HGW=3 ENGINEERING & CONSTRUCTION, a sole proprietorship duly organized and under the law of the Philippines, with principal address at Poblacion, Sablan, Benguet represented herein by its Authorized Representative, **HILBERT BELA-O WILLIE** (hereinafter called the "Contractor");

WHEREAS, the Entity is desirous that the Contractor execute "Improvement/Repair of Existing Policy Development and Planning Bureau Ceiling and Reconditioning of Electrical Wiring and Fixtures" (hereinafter called the "Works") and the Entity has accepted the Bid for **Two Million Thirty Thousand One Hundred Six Pesos and Fifteen Centavos (PhP 2,030,106.15)**, inclusive of all applicable taxes by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General Conditions of Contract (GCC);
 - (b) Special Conditions of Contract (SCC);
 - (c) Drawings/Plans;
 - (d) Specifications;
 - (e) Invitation to Bid;
 - (f) Supplemental/Bid Bulletin;
 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes; and,
 - (h) Notice of Award of Contract and the Bidder's conforme thereto.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants


with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


