The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Disaster Response Management Group (DRMG), FELICISIMO C. BUDIONGAN, (hereinafter called the "PROCURING ENTITY");

-and-

ALL TRANSPORT NETWORK, INC., a corporation organized and existing under Philippine law, with principal business address at 3 Sta. Agueda Ave. Pascor Drive, Sto. Nino, Parañaque City, Philippines, represented herein by its authorized representative, VERNADETTE G. VIVERO (hereinafter called the "SUPPLIER");

WHEREAS, the Procuring Entity through Competitive Bidding invited Bids for certain goods and ancillary services, specifically for "Procurement of Forwarding Services for CY 2020" where four (4) bidders submitted their bid proposal, and after deliberation of the Bids and Awards Committee (BAC) and pursuant to BAC Resolution No. 20-03-059, has accepted the Bid of the Supplier being the Lowest Calculated and Responsive Bidder (LCRB), with the total contract price of ~~Forty Nine Million Eight Hundred Thirty-Two Thousand Two Hundred Eight Pesos (PhP49,832,208.00)~~ (hereinafter called "the Contract Price"), inclusive of all applicable taxes. The contract duration shall commence from receipt of the Notice to Proceed (NTP) to 31 December 2020 or until such time that the total Contract Price has been consumed/utilized whichever comes first.

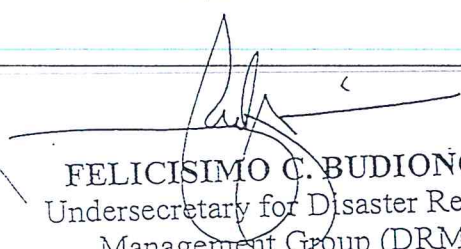

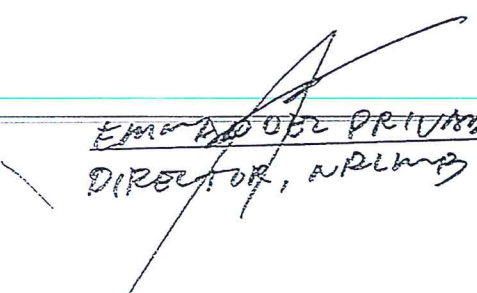

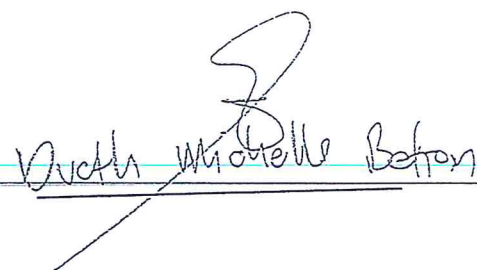
