CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Social Welfare and Development, **DANILO G. PAMONAG, Office of the Undersecretary for Social Welfare and Development** (hereinafter called the "PROCURING ENTITY");

-and-

SANDZ SOLUTIONS PHILIPPINES INC, a corporation organized and existing under Philippine law, with principal business address at 6/F CYA Land Building 110 Rada Street Legaspi Village, Makati City, Philippines, represented herein by its authorized representative, **ALGELINE R. OLILA** (hereinafter called the "SUPPLIER");

In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.


