THIS AGREEMENT made the _____ day of _____ 20____ between DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Undersecretary for Social Welfare and Development, **DANILO G. PAMONAG**, (hereinafter called the "PROCURING ENTITY") of the one part and **IONE RESOURCES, INC.**, a corporation duly organized and existing under and by virtue of the laws of the Philippines and with office address at 1006 Centerpoint Bldg., Julia Vargas Ave., cor. Garnet Road., Ortigas Center, Pasig City, represented herein by its authorized representatives, **MARIA ELIZA S. AUSTRIA** (herein called "THE SUPPLIER") of the other part;

The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
