

CONTRACT AGREEMENT

THIS AGREEMENT made the 29 day of APR 2022 2022 between **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT**, a government agency with principal office address at IBP Road, Constitution Hills, Quezon City, Metro Manila, represented by its Secretary, **ROLANDO JOSELITO D. BAUTISTA**, (hereinafter called the "PROCURING ENTITY") of the one part and **IONE RESOURCES, INC.**, a corporation duly organized and existing under and by virtue of the laws of the Philippines, with office address at 1006 Centerpoint Bldg., Julia Vargas Ave., cor. Garnet Rd., Ortigas Center, Pasig City, represented herein by its authorized representatives, **MARIA ELIZA S. AUSTRIA** (herein called "THE SUPPLIER") of the other part;

WHEREAS, the Procuring Entity through Competitive Bidding invited bids for certain goods and ancillary services, particularly "**SUBSCRIPTION TO MANAGED NETWORK SERVICES FOR DSWD PROGRAMS AND SERVICES**" where two (2) prospective bidders submitted their bid proposal, and after deliberation of the Bids and Awards Committee (BAC), has accepted the Bid of the Supplier being the Single Calculated and Responsive Bidder (SCRB) in the sum of **One Hundred Thirty-Five Million Five Hundred Fifteen Thousand Six Hundred Pesos (Php 135,515,600.00)**, (hereinafter called "The Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement:
 - "(A)" the Bid Form and the Price Proposal Form/Schedule submitted by the Bidder;
 - "(B)" the Schedule of Requirements;
 - "(C)" the Technical Specifications;
 - "(D)" the General Conditions of Contract;
 - "(E)" the Special Conditions of Contract;
 - "(F)" the Supplemental/ Bid Bulletin; and
 - "(G)" the Notice of Award
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


