RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY RAW MATERIALS (NON-FOOD ITEMS) FOR THE PRODUCTION OF SANITARY KITS FOR DISTRIBUTION TO SENIOR CITIZENS AFFECTED BY THE COMMUNITY QUARANTINE AND TO PREVENT THE PANDEMIC SPREAD OF COVID-19

(PR NO. 01-20001-PR2020-03-00240, PR NO. 01-20001-PR2020-03-00242, PR NO. 01-20001-PR2020-03-00243, and PR NO. 01-20001-PR2020-03-00245)

WHEREAS, pursuant to the Proclamation No. 922 entitled "Declaring a State of Public Health Emergency throughout the Philippines", all National Government Agencies and Local Government Units are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the spread of the COVID-19. In line with said declaration the Department of Social Welfare and Development - National Resource and Logistics Management Bureau (DSWD-NRLMB) requested for the Procurement of Raw Materials (Non-Food Items) for the Production of Sanitary Kits for Distribution to Senior Citizens Affected by the Community Quarantine and to Prevent the Pandemic Spread of COVID-19. A copy of the said Proclamation No. 922 is hereto attached, marked as **Annex "A"**, and made an integral part hereof;


