**RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH
EMERGENCY CASES AND AWARD OF CONTRACT FOR THE PROCUREMENT OF
SANITATION SUPPLIES BY DEPARTMENT SOCIAL WELFARE AND DEVELOPMENT –
NATIONAL RESOURCE AND LOGISTICS MANAGEMENT BUREAU
(DSWD-NRLMB)**

**(PR Nos. 01-20001-PR-2020-03-00256, 01-20001-PR-2020-03-00257,
01-20001-PR-2020-03-00259, and 01-20001-PR-2020-03-00260)**

WHEREAS, pursuant to the Proclamation No. 922 entitled “Declaring a State of Public Health Emergency throughout the Philippines” all National Government Agencies and Local Government Units are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the spread of the Covid-19. In line with the said declaration, the Department of Social Welfare and Development – National Resource and Logistics Management Bureau (NLRMB) through its initiative under take necessary and precautionary measures in order to contain prevent and mitigate the spread of COVID-19 within its premises. Hence, NRLMB is requesting for the procurement of sanitation supplies to be used by its personnel, donors, visitors, volunteers, and other workforce stationed in the National Resource Operations Center (NROC). Copies of the said Proclamation No. 922, and Project Proposal are hereto attached, marked as **Annexes “A”** and **“A-1”**, respectively, and are made integral parts hereof;

WHEREAS, the National Resource and Logistics Management Bureau (NRLMB), submitted an approved Purchase Requests (PRs) for the procurement of sanitation supplies in order to safeguard the health and safety of all its personnel, donors, visitors, volunteers and other workforce stationed at NROC, itemized as follows:

WHEREAS, pursuant to the Justification signed by Dir. Emmanuel P. Privado of National Resource and Logistics Management Bureau (NLRMB), there is an urgent need to procure the aforesaid sanitation supplies in order to ensure the health and safety of its personnel, donors, visitors, volunteers and other workforce stationed at NROC. Use of **Negotiated Procurement - Emergency Cases** for the Procurement of Sanitation Supplies to safeguard the health and safety of all its personnel, donors, visitors, volunteers and other workforce stationed at National Resource Operations Center (NROC), pursuant to Section 53.2 of the 2016 Revised IRR of RA No. 9184; and
2. Award of contract to **HLYC TRADING**, in the accordance in the following items:

3. Recanvass **Item No. 3 (Thermometer, Non-Contact Infrared 2 Units)**, because the quotation from the bidder is above the Approved Budget for the Contract (ABC). Further, **End-User Unit (NRLMB) to conduct mandatory review and evaluation of the terms, conditions and specifications to determine the reason for the failed canvass** pursuant to Section 35.2 of the 2016 IRR of RA 9184, prior to the conduct of another round of procurement process.




