Resolution No. 20-07-140**

**RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH
EMERGENCY CASES AND AWARD OF CONTRACT FOR THE CATERING SERVICES
FOR DSWD STAFF INVOLVED IN THE IMPLEMENTATION OF "HATID TULONG"
INITIATIVE FOR LOCALLY STRANDED INDIVIDUALS"
(PR Nos. 01-20001-PR-2020-06-00175)**

WHEREAS, the Department of Social Welfare and Development (DSWD) through the Disaster Response Management Bureau (DRMB) requested an emergency procurement of Catering Services for DSWD Staff Involved in the Implementation of "Hatid Tulong" Initiative for Locally Stranded Individuals under Purchase Request (PR) No. 01-20001-PR-2020-06-00175 with an approved Budget for the Contract amounting to One Million One Hundred Thousand Pesos (PhP1,100,000.00). Copies of the **PR** and **Project Proposal** are hereto attached, marked as **Annexes "A"** and **"B"** respectively, and are made integral parts hereof;

WHEREAS, pursuant to the Proclamation No. 922 entitled "Declaring a State of Public Health Emergency throughout the Philippines", all National Government Agencies and Local Government Units are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the spread of the COVID-19." A copy of the said Proclamation No. 922 is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

WHEREAS, the DRMB, through Director Clifford Cyril Y. Riveral, submitted a justification requesting for the emergency procurement of Catering Service for DSWD staffs to be augmented to aid numerous Locally Stranded Individuals who were stranded in different parts of the country. A copy of the **Justification** is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

WHEREAS, Section 53.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA No. 9184) otherwise known as the Government Procurement Reform Act, allows the use of Negotiated Procurement-Emergency Cases whereby the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier. Negotiated Procurement-Emergency Cases may be resorted on the following instances;

- i. In case of imminent danger to life or property during a state of calamity, or*
- ii. When time is of the essence arising from natural or man-made calamities or*
- iii. Other causes where immediate action is necessary:*
 - a) To prevent damage to or loss of life or property, or*
 - b) To restore vital public services, infrastructure facilities and other public utilities.*

WHEREAS, considering the urgency of the aforesaid request the Procurement Management Service (PMS), through the Procurement Planning and Management Division



(PPMD), immediately prepared Request for Quotation (RFQ) No. 20-0609 NP-Emergency and sent to the following service providers/suppliers:

WHEREAS, the PMS-PPMD exerted all efforts however, only, Social Welfare Employees Multi-Purpose Cooperative (SWEMC) submitted its price quotations within the specified deadline of submission which was not later than 12:00 n.n. of 01 July 2020. A copy of the received **Price Quotation** is hereto attached marked as **Annex "H"**, and made an integral part hereof;

WHEREAS, the BAC, through its Secretariat, conducted evaluation to determine the Lowest Calculated Quotation/Single Calculated Quotation as the case may be. The result of the evaluation is as follows:


