WHEREAS, the Department of Social Welfare and Development (DSWD), through the Information and Communications Technology Management Service (ICTMS), aims to purchase desktop computers and laptop computers to replace the obsolete and ageing computers in the Department. Copies of the Purchase Request (PR) and Technical Assistance Report are hereto attached, marked as **Annexes “A-1”** and **“A-2”** respectively, and are made integral parts hereof;

WHEREAS, the DSWD, through the Bids and Awards Committee (BAC), posted an Invitation to Bid (ITB) for the **Supply and Delivery of Desktop Computers and Laptop Computers for DSWD Central Office and Field Offices** under ITB No. GOP/20-DSWD-012 at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at conspicuous places within the Department premises starting 26 December 2019. The Approved Budget for the Contract (ABC) is **Thirty-Five Million Six Hundred Seventy Thousand Pesos (PHP 35,670,000.00)**, classified in accordance with the following lots:

WHEREAS, the Competitive Bidding Procedure for Goods was adopted in this undertaking pursuant to Republic Act No. 9184 (RA 9184) otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, a Pre-Bid Conference was conducted on 03 January 2020 at 01:30 PM and was attended by the following prospective bidders, to wit:

WHEREAS, on 22 January 2020 at 02:00 PM, during the opening of bids and preliminary examination of the documents submitted by the bidders, the BAC had the following findings:

S1 Technologies Inc. withdraw its bid proposal before the opening of bids. Further, there was no bid received for Lot No. 2 (Laptop Computers). WHEREAS, the BAC, with the assistance of its Secretariat, conducted the Bid Evaluation to determine the Lowest Calculated Bid (LCB) and if there are computational errors in the bid prices submitted by the bidders. The Bid Evaluation found Accent Micro Technologies, Inc. as LCB for Lot No. 1 (Desktop Computers) per recalculated bid price, and which yielded the following result:

WHEREAS, the BAC received the reply of Accent Micro Technologies, Inc. to the Notice of Bid Evaluation wherein the bidder accepted, conformed and agreed to the recalculated bid price. The copy of the letter is hereto attached, marked as **Annex “J”**, and made an integral part hereof;

WHEREAS, for purposes of conducting the Post-Qualification, the BAC requested Accent Micro Technologies, Inc., being the LCB for Lot No. (Desktop Computers), to submit additional documents within five (5) calendar days from receipt of notice, pursuant to Section

34.2 of the 2016 Revised IRR of RA 9184. A copy of the Notice of Post-Qualification is hereto attached, marked as **Annex "K"**, and made an integral part hereof;

WHEREAS, the BAC created a TWG pursuant to Section 12 of the 2016 Revised IRR of RA 9184 that will conduct the Post-Qualification of Accent Micro Technologies, Inc. A copy of the said creation of TWG is hereto attached, marked as **Annex "L"**, and made an integral part hereof;


WHEREAS, on 10 February 2020, the BAC received the TWG report which found Accent Micro Technologies, Inc. as "Responsive" to all the requirements stipulated in the Bidding Documents. A copy of the said TWG report is hereto attached, marked as **Annex "M"**, and made an integral part hereof;


WHEREAS, the BAC discussed and deliberated the merits of the TWG report during its Regular Meeting on 13 February 2020. The BAC found that Accent Micro Technologies, Inc. is legally, technically and financially capable to provide the goods and services needed by the DSWD, and thus resolved to recommend award of contract to Accent Micro Technologies, Inc. A copy of the Minutes of Regular Meeting is hereto attached marked as **Annex "N"**, and made an integral part hereof;

NOW, THEREFORE, in view of the foregoing and on the basis of the documents presented, we, the Bids and Awards Committee, resolves as it is hereby resolved to:

1. **Recommend award of contract for Lot No. 1 (Desktop Computers) for the Supply and Delivery of Desktop Computers and Laptop Computers for DSWD Central Office and Field Offices** under ITB No. GOP/20-DSWD-012 to **Accent Micro Technologies, Inc.**, being the **Lowest Calculated and Responsive Bid (LCRB)**. The Total Contract Price is **Eleven Million Two Hundred Five Thousand Two Hundred Forty-One Pesos and Sixty Centavos (PHP 11,205,241.60)**, inclusive of all applicable taxes;
2. **Declare a failure of bidding for Lot No. 2 (Laptop Computers) for the Supply and Delivery of Desktop Computers and Laptop Computers for DSWD Central Office and Field Offices** under ITB No. GOP/20-DSWD-012 because no bid received during the deadline of submission and receipt of bids; and,
3. **Advise the End-user to conduct a mandatory review and evaluation** of the terms, conditions and specifications in the Bidding Documents, including the cost estimates and **sources of funds if it is still available**, to determine the reason for the failed bidding for **Lot No. 2 (Laptop Computers)**, pursuant to Section 35.2 of the RA 9184, prior to the conduct of another procurement process.


