**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF
LAPTOP COMPUTERS FOR DSWD CENTRAL OFFICE AND FIELD OFFICES**

WHEREAS, the Department of Social Welfare and Development (DSWD), through the Information and Communications Technology Management Service (ICTMS), aims to purchase desktop computers and laptop computers to replace the obsolete and ageing computers in the Department. Copies of the Purchase Request (PR) and Technical Assistance Report are hereto attached, marked as **Annexes “A-1”** and **“A-2”** respectively, and are made integral parts hereof;

WHEREAS, on 17 February 2020, the Bids and Awards Committee (BAC) issued Resolution No. 20-02-019 recommending award of contract for Lot No. 1 (Desktop Computers) and failure of bidding for Lot No. 2 (Laptop Computers) for the **Supply and Delivery of Desktop Computers and Laptop Computers for DSWD Central Office and Field Offices** under ITB No. GOP/20-DSWD-012. The said resolution was approved by the Head of the Procuring Entity, as delegated. A copy of the said resolution is hereto attached, marked as **Annex “B”**, and made an integral part hereof;

WHEREAS, on 30 March 2020, the BAC issued a memorandum to the ICTMS, informing the latter of the results of the bidding for the abovementioned procurement. A copy of the said memorandum is hereto attached, marked as **Annex “C”**, and made an integral part hereof;

WHEREAS, on 07 April 2020, the ICTMS, through Director Andrew J. Ambubuyog, issued a memorandum to the BAC requesting the former to conduct another bidding process Lot No. 2 (Laptop Computers) for the abovementioned procurement with no changes in the terms, conditions and specifications in the previous Bidding Documents and its Supplemental/ Bid Bulletins. A copy of the said memorandum is hereto attached, marked as **Annex “D”**, and made an integral part hereof;

WHEREAS, the DSWD, through the Bids and Awards Committee (BAC), posted an Invitation to Bid (ITB) for the **Supply and Delivery of Laptop Computers for DSWD Central Office and Field Offices** under ITB No. GOP/20-DSWD-012-A at the Philippine Government Electronic Procurement System (PhilGEPS) and DSWD websites, and at conspicuous places within the Department premises starting 15 April 2020. The Approved Budget for the Contract (ABC) is **Twenty-Two Million Two Hundred Thirty Thousand Pesos (PHP 22,230,000.00)**. Copies of the said ITB and proof of postings are hereto attached, marked as **Annexes “E-1”**, **“E-2”**, **“E-3”** and **“E-4”** respectively, and are made integral parts hereof;

WHEREAS, the Competitive Bidding Procedure for Goods was adopted in this undertaking pursuant to Republic Act No. 9184 (RA 9184) otherwise known as the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations (IRR);



WHEREAS, a Pre-Bid Conference was conducted on 22 April 2020 at 11:00 AM and was attended by the following prospective bidders, to wit:

1. Accent Micro Technologies, Inc.; and
2. Joneco Tech Marketing Corp.

WHEREAS, the BAC, with the assistance of its Secretariat, conducted the Bid Evaluation to determine the Lowest Calculated Bid (LCB) and if there are computational errors in the bid prices submitted by the bidders. The Bid Evaluation found Joneco Tech Marketing Corp. as LCB, and which yielded the following result:

WHEREAS, the BAC created a TWG pursuant to Section 12 of the 2016 Revised IRR of RA 9184 that will conduct the Post-Qualification of Joneco Tech Marketing Corp. A copy of the said creation of TWG is hereto attached, marked as **Annex "M"**, and made an integral part hereof;

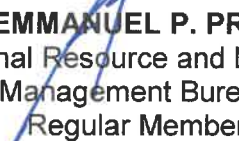

WHEREAS, the BAC discussed and deliberated the merits of the TWG report during its Regular Meeting on 20 May 2020. The BAC found that Joneco Tech Marketing Corp. is legally, technically and financially capable to provide the goods and services needed by the DSWD, and thus resolved to recommend award of contract to Joneco Tech Marketing Corp. A copy of the Minutes of Regular Meeting is hereto attached marked as **Annex "O"**, and made an integral part hereof;

The Total Contract Price is **Thirteen Million Nine Hundred Fifty-Five Thousand Five Hundred Pesos (PHP 13,955,500.00)**, inclusive of all applicable taxes;
