Eligibility Requirements: <ul style="list-style-type: none"> • Mayor's Permit 	May the BAC extend the date of submission or allow the Bidder/Service Provider to submit their 2018 Mayor's/Business Permit during the opening of bids, and to submit the renewed Mayor's/Business Permit for 2019 during the Post Qualification stage of the bidding process?	<p>The Bidder/ Service Provider who submit their Certificate of PhilGEPS Registration (Platinum Membership) should be valid during the deadline of submission and receipt of bids. However, for those Bidder/ Service Provider which has been determined to have submitted a valid Certificate of PhilGEPS Registration (Platinum Membership) but with expired eligibility documents as listed in Annex A, should be required to submit their updated documents during the Post-Qualification Stage of the Bidding Process, if such Bidder/ Service Provider have been determined to be the Lowest Calculated Bidder/ Single Calculated Bidder, as the case may be.</p> <p>Likewise, for the Bidder/ Service Provider who opted to submit their Eligibility Documents instead of their PhilGEPS Certificate of Registration (Platinum Membership), these Eligibility Documents must be valid. If 2019 Mayor's/ Business Permit is not available, the expired 2018 Mayor's/ Business Permit shall be accepted together with Official Receipt as proof that the bidder has applied for renewal, provided that the renewed permit shall be submitted as a Post-Qualification requirement.</p>
