Cost of Bidding Documents	In the previous bidding, a bidder was able to purchase bidding documents for Lot Nos. 1 & 2, and since there was a failure of bidding for Lot No. 1, is the bidder still required to purchase the bidding documents to be able to participate in the new bidding process?	Yes, the bidder is still required to purchase the Bidding Documents with the cost specified in the Invitation to Bid (ITB).

ITB Clause 5.4 "The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC."	Can the DSWD reduce the SLCC to at least twenty-five percent (25%) of the ABC, or aggregate of multiple contracts of similar nature and the aggregate contract amount must be equivalent to 50% of the ABC and the largest of which must be at least equivalent to twenty-five percent (25%) of the ABC to be bid? Yes, a bidder can join and win both lots provided that the network backbone or network facility of DSWD Central Office and 16 Field Offices is different from that of Lot 2.
