II. Section VII. Technical Specifications

Question:

1. On Page 67 of the Bidding Documents, under Value Preposition, it stated that "Additional layer of protection using encryption and mobile device management" but there is no mention of what kind on encryption is required?

Response:

The entire solution covers desktop, laptops and mobile devices, so the solution must be capable of mobile device management (MDM). Some of the features of MDM would be encryption, device lockdown and other features in just a single license.

Ouestion:

2. Would the DSWD consider the built-in encryption on the mobile devices?

Response:

The encryption should be managed by the MDM of the enterprise solution. It will be used in isolating applications of DSWD for mobile and locating and securing the contents. Most of the devices issued to the End-users contain sensitive data. DSWD will use the end-point solution to secure the data being used by DSWD field personnel.

Question:

3. Does DSWD have any requirement of a particular encryption algorithm?

Response:

It should be part of the MDM module of any solution.

Question:

4. On Page 74 of the Bidding Documents, item 1.4.1. states that "Should provide a module for data leakage protection using a single agent", is DSWD requiring for the data linkage protection (DLP)?

Response:

Yes, it should be part of the endpoint protection license.

Question:

5. What are the features included in the DLP?

Response:

DSWD wanted a full feature DLP that can define custom formats like household ID number to prevent anyone from transmitting a certain list of households to and from the internet or local device so that DSWD can prevent copying or exporting large amounts of data outside of DSWD without permission.

Question:

6. Can the DSWD reduce the Single Largest Completed Contract (SLCC) from 50% to at least 40% of the ABC?

Response:

No. DSWD cannot reduce the SLCC to at least 40% of the ABC. The subscription of antivirus and anti-malware solutions are categorize as <u>Services</u>. Thus, the Procuring Entity cannot reduce the required percentage of the SLCC as provided in Section 23.4.1.3. of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, and in ITB Clause No. 5.4 of Section III. Bid Data Sheet of the Philippine Bidding Documents prescribed by the Government Procurement Policy Board (GPPB).

III. Deadline for the Submission and Receipt of Bids

The schedule for the deadline for the submission and receipt of bids is moved from 09 July 2018 to **11 July 2018** at **01:00 p.m.** Bids must be delivered to the BAC Secretariat Office, Ground Floor, DSWD Central Office. Late Bids will not be accepted.
