1.	Item 1.3: Overall Length / Width / Height: At least 5,700 mm X 1,900 mm X 2,100 mm	Is the DSWD amenable to reduce the width or at least to 5,265 mm X 1,950 mm X 1,990 mm?	No changes. The DSWD prefers more to a wider, higher and spacious vehicle for service of its employees and staff.	
2.	Item 1.4. Wheelbase: At least 3,600 mm	Is the DSWD amenable to reduce the wheelbase from at least 3,600 mm to at least 3,210 mm?	No changes. Vehicles with longer wheel-base have better ride comfort than the vehicles with shorter wheel-base.	
3.	Item 1.8. Transmission: 6-Speed, Automatic	Is the dswd amenable to reduce the transmission from 6-speed to 5-speed?	No changes. The higher the transmission would entail powerful high gear speed.	
4.	Item 1.6.2. Engine Displacement: At least 2,750 but not exceeding 3,000 cc	Is the specification for engine displacement final?	Yes, since DSWD need a more powerful engine to cater the daily shuttle needs of the passengers.	
5.	Item 1.19.4. Stickers	Please provide copies of the actual dswd logo and "for official use only" with dimensions.	Please see Annex "A".	
6.	Item 1.20. Manufacturer and its Service Centers should be at least 40 years in the industry.	Is the DSWD amenable to reduce the number of years for the manufacturer in the industry and its service centers to 20 years?	No changes. DSWD requires that the supplier are well-known in the automotive industry and had established economic stability thus 40 years in the industry is required.
