This Supplemental/ Bid Bulletin is issued to all prospective bidders announcing clarifications in the Bidding Documents and changes in the procurement schedule, to wit:

### I. Section VII. Technical Specifications

**Question:**

1. When do the service provider submits a copy of the Closed Circuit Television (CCTV) footage to the DSWD?

**Answer:**

**Recordings/Copy of CCTV footages shall be submitted to the Administrative Service Director on a monthly basis.**

**Question:**

2. What is the bond of One Thousand Pesos (PhP 1,000.00) for security personnel for?

**Answer:**

**The bond of PhP 1,000.00 for security personnel is a requirement of the Philippine Association of Detective and Protective Agency Operators, Inc. (PADPAO).**

**Question:**

3. What does the provision on page 68, item 4.4. of the Bidding Documents “..... The compact disc or any other applicable tool to save the surveillance monitor shall become the property of the Department, which shall have the right to retain and/or erase the content of the said storage device/means” means?

**Answer:**

**The provision means that the service provider can retain copies of the CCTV footages, however, they cannot disclose the footages or any portion thereof to any third (3<sup>rd</sup>) party without the explicit written consent of DSWD.**

### II. Deadline for the Submission and Receipt of Bids

The schedule for the deadline for the submission and receipt of bids is moved from 05 February 2018 to **07 February 2018 at 01:00 p.m.** Bids must be delivered to the BAC Secretariat Office, Ground Floor, DSWD Central Office. **Late Bids will not be accepted.**

The Bid Opening will immediately follow after the deadline, to be held at the Legal Service Conference Room, 4<sup>th</sup> Floor, DSWD Central Office, IBP Road, Constitution Hills, Quezon City.
