Hiring of Service Provider for Customs Brokerage and Cargo Hauling Services for FY 2020

1. Contract Duration

The contract duration shall commence from the receipt of Notice to Proceed (NTP) or until 31 December 2020 or until such time that the Total Contract Price (TCP) has been consumed, whichever comes first.

2. Cost/Pricing to be Used as Reference for Brokerage and Cargo Hauling Services:

Any additional services that will be rendered by the CUSTOMS BROKERAGE AND CARGO HAULING FIRM due to unforeseen circumstances or emergency situations which

will result to an excess in the amount of the approved budget shall be funded and justified by the requesting office.

3. Terms of Payment

The payment shall be made on actual services rendered and payable within fifteen (15) to thirty (30) calendar days after the transaction and submission of the Summary of Billing Statements/ Sales Invoices and/or Official Receipts under the Charge Account. All Billing/Rates shall be subject to all applicable taxes.
