## SUPPLEMENTAL BID BULLETIN NO. 1

Engagement of an Integrated Communication Agency for the

This Supplemental/ Bid Bulletin is issued to all prospective bidders announcing the response on the questions raised by the prospective consultancy firm/service provider and the amendments/changes in the procurement schedule, as follows:

- I. Questions for clarifications raised by the prospective consultancy firm/service provider
  - 1. When are the target dates for implementation of the training?

Response: There are no specific dates yet for the conduct of this activity due to our current situation on the pandemic COVID19. However estimated date will be on the later part of June 2020, after ten (10) days upon receipt of the Notice to Proceed (NTP).

2. How many participants are being targeted for this?

Response: There will be forty (40) DSWD personnel composed of the Secretariat, Regional Officers, and Information Officers of Offices/Bureaus/Services/Units (OBSUs) who are expected to attend the training.

3. Will the training be held face-to-face?

Response: Yes. The target venue will be SWADCAP DSWD, 111 Block 5, Taguig, 1630 Metro Manila.

4. What specific topics are you looking at for digital media training?

Response: The topics will be more on the Social Media & Community Management's side since the training aims to:

- a. Equip information officers with the capability to design the communication strategies; choose communication tactics; and create a measurement framework based on the identified stakeholders and communication objectives;
- b. Capacitate information officers to understand the communication problems and identifying stakeholder and other factors that could affect the promotion of the Department programs and service.
