1. Question: There is no size for 5/32'' Black Screw, is it probably 1/8''?

Answer: DSWD is amenable to revise the size of Black Screw from 5/32" to 1/8"

2. Question: What kind of Handle T-Bar does DSWD required? Please be specific.

Answer: DSWD requires Handle T-Bar, 3/8'' Ø in different length/size (by 3'', 4'', 5'', 6'' and 8''), stainless. Please see attached sample.

3. Question: What is the length of Bolt and Nut Full Thread and the diameter?

Answer: DSWD requires Bolt and Nut Full Thread $\frac{1}{4}$ " Ø in different length/size (by 2", 3", 4" and 5") with washer.

4. Question: Is the Bolt and Nut Full Thread 5" with washer not included in the Price Proposal Form?

Answer: DSWD will revise the Price Proposal Form to include said item.

5. Question: Can we revise/adjust the delivery period from 15 calendar days to 30 calendar days? The prospective bidder needs sufficient time to prepare and purchase the items to the supplier.

Answer: DSWD agreed to revise the delivery period from 15 calendar days to 30 calendar days.




