- 2. The DSWD now invites bids for the Rental of Information Technology (IT) Equipment for Interim Shelter Fund Project Coordination Office (ISFPCO). The delivery of goods shall be within seven (7) working days from receipt of the Notice to Proceed (NTP). Bidders should have completed within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from DSWD Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from Mondays to Fridays at 8:00am to 5:00pm.

- 6. Bids must be delivered to the address below on or before **10:00 a.m.** of **07 January 2015**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **07 January 2015**, **10:00 a.m.**, at the **Directors Dormitory** (Executive Lounge), **DSWD Central Office**, **IBP Road**, **Constitution Hills**, **Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
