# HIRING OF CONSULTING FIRM TO CONDUCT AN ONLINE SEMINAR ON CERTIFIED INTERNAL AUDITOR (CIA)

-DSWD NNP No. 20-GOP-SVCF-007-(PR No. 01-20001-PR-2020-09-00069)

- The Republic of the Philippines, through the Internal Audit Service Current Appropriation Funds, of the Department of Social Welfare and Development (DSWD), intends to apply the sum of Six Hundred Thousand Pesos (PhP 600,000.00) being the Approved Budget for the Contract (ABC) as payment for the "Hiring of Consulting Firm to Conduct an Online Seminar on Certified Internal Auditor (CIA)" (DSWD NNP No. 20-GOP-SVCF-007)
- 2. The project aims to engage a reputable professional organization dedicated to the advancement of the internal auditing profession that shall provide an online training and encourage participants to take and pass the CIA examination for CIA Certification that would upgrade and improve the capacity of DSWD Internal Audit Staff, the Regional Management and Audit Analysts in the field of internal auditing.

### 3. Scope of Work are as follows:

After conducting consultations, review of necessary documents, the integrated communication agency shall work jointly with the Internal Audit Service (IAS) Director, key project staff, and other consultants in carrying out the following tasks:

- 1. Prepare the design for the three (3) part CIA seminar;
- Administer a mock examination before the start and at the end of the seminar to gauge the increase in knowledge.
- 3. Conduct and facilitate the seminar based on the agreed or approved design and methodology; ands
- 4. Prepare and submit documentation of the seminar.

#### 4. Degree of Expertise, Qualification, and Competencies:

The Communication Agency should possess an extensive experience in undertaking the required services as detailed in the scope of work and with the following qualifications, to wit:

- Established organization duly recognized by the Securities and Exchange Commission (SEC);
- b. Has experience in working with government specifically on providing CIA seminar:
- c. Must have undertaken ten (10) CIA seminar within the last ten (10) years; and
- d. Has a pool of resource persons with qualifications and expertise in performing internal auditing.
- e. Recognized by an international organization as Center for Excellence in Certification;





5. In consideration with consultancy services required, payment of the consultant/ service provider shall be made in accordance with the following schedule:

The Department shall pay the communication agency/ service provider of the Total Contract Price (TCP) is inclusive of all applicable taxes (withholding tax), professional fees and transportation costs of facilitators, documenters, and resource persons and other out-of-pocket expenses, e.g. workshop materials, and other logistical costs.

Full payment shall only be made upon the completion of the workshop, submission of narrative documentation report, and terminal report with communication plan and corresponding recommendations.

6. This project shall be procured using Section 53.9 (Negotiated Procurement-Small Value Procurement) of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act and pursuant to the following criteria:

  - iv) Income Tax Return; and
  - v) Notarized Omnibus Sworn Statement (Annex B), to be submitted by the awarded communication agency;
