1. The Republic of the Philippines, through the Department of Finance, has received a loan (Loan Agreement No. 9168-PH) from the International Bank for Reconstruction and Development (IBRD). The Department of Social Welfare and Development (DSWD) is an Implementing Agency of the Beneficiary FIRST Social Protection Project, with the Pantawid Pamilyang Pilipino Program - National Program Management Office (4Ps-NPMO) playing the role of Project Management Unit (PMU), and intends to apply part of the loan to payments under the contract for the following consulting services:

The DSWD now invites eligible individual consultants to indicate their interest in providing the consulting services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The candidates will be evaluated based on knowledge, experience, and skills, and required qualifications can be found from the attached Terms of Reference (TOR) for respective position.
